01	The Universal Declaration of Human Rights (UDHR)	01	It is the Law No. 25-14 dated on 3 August 2025, published in the Official Gazette of the Algerian Republic, Issue No. 54, dated 3 August 2025. This law comprises 890 articles, setting out the conduct of public proceedings from start to finish.
