## **Introducing Disciplines and their Objectives**

## First: The Department of Law Bachelor's Level Specializations:

1- Private Law:

The law regulates the rights and obligations of individuals and governs their private relationships with each other, which the state or any of its members do not have a relationship with. It is referred to as the General Law or Civil Law, which mostly contains provisions for these relationships.

✓ <u>Objectives of the specialization</u>: The student gains knowledge through the study of the specialized subject of Private Law, mainly the ways of interaction between individuals in their

different contracts, and understanding of judicial dealings with the courts regarding private matters such as family, business affairs, work relationships, etc.

## 2- Public Law:

Public law regulates the relationship between the State and its regional and auxiliary bodies, and governs the principles followed by the state in regulating its external relations with other countries through international treaties. It reflects the sovereignty of the state within its territory and the nature of its relationship with its citizens.

#### • The Objective of the Specialization

The student acquires knowledge through his study of the major topics of Public Law, especially the state as a legal entity, its components and the principle of sovereignty within it, the ways it originated, and the different types of states, such as the government and the meaning of democracy, elections, political parties, and the various legislative, regulatory and judicial powers, etc.

#### Master's Specialties:

#### 1- Administrative Law (Academic): .

This specialization studies everything related to public law that is related to administrative issues or the so-called science of Public Administration, and everything in which the state stands out with its sovereignty and the privileges of its public authority, such as administrative, constitutional law, public funds, administrative disputes, the science of Public Administration and other subjects.

**Objectives of the Specialty:** The student acquires knowledge through his study of Administrative and Constitutional Law and the system of public finances and public transactions and other subjects taught during the course, and aims to train students to be able to work in all fields of public administration, not to mention other branches such as judiciary and law, etc.

## 2. Business Law (Academic)

It studies all aspects of Business Law, particularly those with an economic value, such as commercial companies, Stock Exchange Law, Banking Law, Investment Law, contracts, lawyers, and judges.

• **Objectives of the Specialty**: The goal of this discipline is to educate students about Business Law, particularly financial contracts and investment, and equip them with the skills needed to work in the fields of financial institutions, accounting, commerce, and as lawyers and judges.

#### 3. Real Estate Law (academic)

This specialization studies everything related to real estate law, especially the methods of acquiring real estate ownership, the powers of the owner, and how to exercise the right of ownership and the rights derived from it. It also teaches how to handle disputes that arise from real estate, such as ownership certificates or exploitation, and other real estate issues.

• **Objectives of the Specialty** The goal of this discipline is to educate students about real estate law, including the original rights of property ownership and how to handle real estate disputes. The discipline also aims to prepare students to work in administrative roles in real estate, such as property managers, in the responsible government agencies.

Through his study of the specialty, the student acquires knowledge of the topics of real estate law, especially the original in-kind rights to the right of ownership and its branches, as well as identifying how to handle real estate disputes, jurisdiction, and others .it also aims to train students who can occupy positions of an administrative nature in the administration in charge of real estate such as state property, real estate conservation, land surveying, reconstruction and construction, lawyers and judges..Etc..

4- **Judicial Law (Professional):** This field of study covers all aspects of judicial law, judicial organization, ordinary and administrative justice, and other judicial professions such as judicial clerks, lawyers, mediators, conciliation, and others, in addition to professional ethics and other related topics.

## **Objectives of the Specialty:**

Through his study of the specialty, the student acquires knowledge of the topics of the judicial profession on how to adjudicate lawsuits procedurally and objectively, an understanding of the judicial organization in its various degrees, knowledge of alternative ways to resolve disputes and others, and aims to form students who can occupy jobs of a judicial or quasi-judicial nature, especially in the field of judiciary, police, penal institutions, lawyers and judicial assistants.

5- Crime and Security (Professional): This field of study covers all aspects of the science of crime, punishment, and judicial organization that is responsible for resolving criminal cases, implementing court decisions and rulings, etc..

**Objectives of the Specialty**: The student gains knowledge of crime and punishment, the skills to control and investigate these crimes, and the procedures for resolving them. The aim is to train students to be able to occupy judicial or quasi-judicial positions, especially in the fields of judiciary, judicial police, penal institutions, lawyers, and judicial clerks.

## Second: Department of Political Sciences:

## **Undergraduate Specializations:**

# **1- International Relations:**

The international relations specialization studies multiple research disciplines including economics, history, political science, contemporary issues such as human rights, environment, poverty, public policy problems, etc.

**Objectives**: The student will acquire knowledge of political-economic topics, understand global economic and political conflicts and work on interpreting them, analyze economic, cultural and political phenomena, understand global issues and how to interact with them.

# 2- Political and Administrative Regulation:

The specialization (political and Administrative Organization) studies Economics, Management Science and other fields related to political life and the relationship of Public Administration with each other, and individuals within the framework of the relations of the public facility with its visitors.

**Objectives**: The student will acquire knowledge of Political Administration and Public Administration topics, be able to identify and understand the principles, methods, and techniques of human resource management and development, comparative policies, public service management, local community management, etc.

## Master's Specialization in Public Policy:

#### **1-** General Policies (Academic):

Public policy is a set of ideological orientations that the government aims to achieve its goals by relying on a set of means and tools. Public policy may include providing a set of public benefits, such as providing convenient transportation routes, contributing to the provision of many services to the community.

#### **Objectives of Specialization:**

<u>Determination of Public Policy</u>: It is the stage at which the nature of the public policy that will be applied in a society is determined, by adopting the link between the political plans written on paper, the resources available for their implementation, and the general reality in society.

Making a public policy and using the appropriate political plan to implement it, by taking advantage of the available resources, by formulating a set of expectations and possibilities that help to build a public policy in the right way.

#### **Objectives of Doctorate Formation**

#### The Objectives of Doctoral Formation generally include:

- Preparing Doctorate students to become knowledgeable and analytical researchers who can produce academic and scientific knowledge.
- Cultivating a spirit of creativity and continuous intellectual development.
- Preparing students and qualifying them to obtain a Doctorate Degree to be qualified to work in the teaching sector in academic institutions, assume other public functions, run institutions and others.
- Enabling students to achieve high professional goals and play leadership roles in Algerian society.
- Preparing students to address legal problems and issues.
- Enabling students to develop critical thinking skills..

#### 1- The Objectives of Doctorate Formation in Real Estate Law:

- Studying the legal framework of real estate ownership and evaluating it in light of new state trends regarding mechanisms for establishing real estate ownership and clarifying its legal status for its three forms: private, national, and waqf (endowment).
- Activating legal protection mechanisms for real estate ownership to enhance its role in economic life.
- Studying the legislative policy regulating investment operations and its role in the development of Economic real estate through the means of granting and exploiting national private real estate properties such as industrial, tourist, agricultural and real estate targeted for Real Estate Promotion.
- Activating the economic role of Endowed Real Estate by studying the ways of exploitation and investment of agricultural endowed real estate, methods of exploitation and investment of endowed real estate of an urban nature.

## 2- Objectives of Doctorate Formation in Administrative Law:

- Addressing modern concepts of the public facility based on the citizenship of the facility, the abandonment of the state facility and the search for ways to involve the beneficiaries in the operation of the public facility.
- Expanding the theoretical knowledge of students regarding issues of public interest and peacebuilding.
- Training legal researchers in the field of digitalization and presenting proposals on the issues generated by digitalization in the economic sector.

## 3- Objectives of Doctorate Formation in Business Law:

- Establishing a legal framework for regulating electronic business practices according to their specificity.

- Evaluating the consumer protection policy related to electronic consumers and providing solutions to the difficulties imposed by the health crisis and its impact on the market.

- Adapting the legal texts regulating the responsibility of pharmaceutical institutions in line with the repercussions of the health pandemic.

## 4- Objectives of Doctorate Formation in Constitutional Law:

- Establishing new rules and mechanisms to promote the activity of constitutional institutions in accordance with the new directions of the state, including coordinating the work of the three authorities and cooperating with each other within the legal frameworks while ensuring that the powers do not overlap.

- Expanding the areas of work of the constitutional supervisory bodies in order to enshrine effective constitutional justice in line with the current political and social conditions.
- Strengthening and promoting political activity to create a political work environment that guarantees the aspirations of citizens, including the creation of the activities of political parties and their role in the upbringing and political formation, especially with its openness to the category of youth, women and holders of scientific degrees

# 5- Objectives of Doctorate Formation in Political Sciences, specialization of Local and Regional Management and Development

It aims to provide students with a comprehensive understanding of local authorities, particularly in terms of legal, administrative, organizational and regulatory frameworks at the national level. The program also seeks to train and prepare human resources to become effective instruments for local governance, particularly local administration and public services. Additionally, students will benefit from theoretical and methodological training through practical field training in local administration in order to link their knowledge with reality and contribute to its improvement through scientific and systematic means.

#### 6- Objectives of Doctorate Formation in Political Sciences, Specialty of African Studies

It aims to increase and deepen the student's knowledge in the field of African International Relations, and to equip them with tools for achieving sustainable development in Africa through scientific studies. At the developmental level, this training also aims to link the university with its economic and social environment regionally and internationally, through agreements concluded with African international universities Tunisia, Senegal, and Mauritania.

It also aims to develop analytical, conceptual, and control skills in new research tools in political science and international relations, to turn the student from a passive recipient of knowledge into a critical thinker through the application of methodological tools, to provide the student with opportunities to develop their own perspectives on proposed topics, and to train them in skills of argumentation and proper construction of ideas.
